US Marshals and outlaws – the stuff of legend, film, and fantasy. Fort Smith saw some of the worst bad men and hosted the court of Isaac Parker, the judge they feared. At the newly opened (July 1<sup>st</sup>, 2023) US Marshals Museum we can explore the roots of the Marshals service through some of their many high profile cases. Visits to the Museum of History and Miss Laura's, formerly a bordello, and a trolley ride, round out the trip into Fort Smith's facts and fiction.
